### **Notice Concerning Organizational Changes and Personnel of Officers**

RENOVA Inc. announces that, at a meeting of the Board of Directors held today, it resolved to implement changes of its organizational changes and changes in personnel.

#### 1. Changes of Organization

The current Operations Division will be divided into the Biomass Operations Division and Operations Division. Biomass Operations Division will specialize in the operation of biomass power plants in operation and under construction in Japan. The Operations Division will continue to be responsible for the operation of existing Solar PV and Wind power plants in Japan and overseas, and will strengthen efforts to improve the management and operational functions and safety of power plants in operation and under construction overseas.

In addition, the Project Management Division will be renamed the Project Development Division, and will accelerate the development of renewable energy power generation (IPP) projects in Japan. At the same time, the Group will strengthen its structure to expand its Green Transformation (GX) business.
